## **Minutes of St Kew Parish Council Meeting held on Tuesday 14<sup>th</sup> April 2015 at 7.30 pm in St Kew Parish Hall**

### **899. Public Discussion**

Discussion regarding the turbine application for PA15/00831 was deferred until Minute 905. There were no other items raised

### **900. Chairmans Announcements**

The Chairman opened the meeting and announced that Emma Hambly had tendered her resignations as Councillor for Pendoggett Ward and notices had been placed advising of the vacancy. He thanked the other Councillors and the Clerk for their support in what had proved to be a difficult two years.

### **905. Planning Notices**

**PA15/00831 – Mr Clive Bax, Land East of Tregorden Farm, Bodieve - Construction of one maximum tip height of 36.6m wind turbine with control box and all associated works. As consultees only**

The meeting was adjourned to allow presentations from the public. All present were against the proposal. The meeting was reconvened.

The application was viewed by Cllrs Mott and R Godden. It was proposed by Cllr R Godden and seconded by Cllr Parnell that the Parish Council recommends **REFUSAL** for the following reasons. Despite the reduction in height from the previous application this does not negate the fact that the visual impact sustained would be irreparable. It will be far too close to the scheduled monuments of Three Holes Cross and Killibury Fort and to the AONB and Camel

Estuary, too close to the A39, and an extreme distraction to motorists, thus compromising road safety.
