## **Minutes of St Kew Parish Council Meeting held on Tuesday 9<sup>th</sup> December 2014 at 7.30 pm in St Kew Parish Hall**

County Councillor S Knightley and PC Taylor were present with 12 Members of the public

### **838. Public Discussion**

Mrs B Gabriel thanked the Parish Council for their support with the new kitchen installation in the Parish Hall. The cost had been around £40000 with only £11,500 received in grants. The balance being raised by the committee. The Council congratulated those concerned on an excellent job.

### **839. Chairmans Announcements**

The Chairman opened the meeting. He advised that new speed limits had now been imposed on the B3314, which included a new 30mph limit through Pendoggett.

### **840. County Councillor and Police Reports**

PC Taylor said that there were no crimes to report in November in St Kew. He advised that Sgt Andy Stuart had replaced Sgt Moorcroft, and that he himself was retiring in January. The Council thanked him for his support over the years.

Cllr Knightley said the budget for Cornwall Council had been accepted and millions had been taken away from the County. Cuts were being made throughout all areas and departments. The Neighbourhood plan for Wadebridge was coming to fruition and a referendum would be held.

Proposed by Cllr Rowe seconded by Cllr A Godden it was AGREED that the Minutes of this meeting be a true and accurate record. All present at the meeting were in favour.

**844. Schedule of monthly accounts for November 2014**

Proposed by Cllr Parnell and seconded by Cllr Rowe that the monthly accounts be approved en bloc. Cllr Hambly abstained. All others in favour.

**845. Review of Polling Places (834)**

A reply received from the Boundary Commission. Cllr Mott asked this to be put on the Agenda for next month so that Councillors can raise any points. **ACTION:** Clerk circulate reply and put on January Agenda

**846. Cornwall for Change (831)**

The meeting at Camelford was attended by Cllr Mott, D Godden and the Clerk. Proposed by Cllr R Godden seconded by Cllr Hambly that the Clerk write a letter of support. Cllr Rickard was against the proposal, all others in favour. **ACTION:** Clerk to write to Chacewater Parish Council

**847. Affordable Housing (682)**

Cllr R Godden asked what had happened to the affordable housing survey. Cllr Parnell said that there was a surprisingly small response but the majority were positive. It was proposed by Cllr Parnell and seconded by Cllr Godden that Trand Living be given the results of the survey. **ACTION:** Clerk to report results

**848. Willow trees below “Wenrin” Chapel Amble Green**

Cllr Rickard has received a request to trim trees planted on the green. Proposed by Cllr R Godden and seconded by Cllr Rickard that a site meeting be held. All in favour. **ACTION:** Cllr Rickard to arrange suitable date.

**849. Parish Councillors Reports and any other matters**

Cllr R Godden reported that there was no plan of common land in Tregellist, **ACTION:** Place on January Agenda

Cllr Rickard said that the bridge that was washed away in Chapel Amble had been replaced by a superior bridge.

Cllr Hambly said that the Smeathers Farm turbine appeal had been withdrawn.

Cllr Mott had attended the meeting of the Middle Treworder Community funding panel, and there will be a further £20k available for grants available later in the year. . Cllr R Godden asked what had happened to the funding from Benbole Solar Farm. **ACTION:** Clerk to investigate.
