Minutes of St Kew Parish Council Meeting held on Tuesday 13 March 2012 at 7.30 pm in St Kew Parish Hall

384 Chairmans Announcements

The Chairman opened the meeting and advised that due to the incorrect procedure of the last meeting ((377) that the Grass Cutting tenders would be revisited and that it was proposed by Cllr Mott seconded by Cllr Hawkey that the votes should be taken by secret ballot. All in favour.

385 Adjournment

The Chairman adjourned the meeting to allow public discussion. Mr J Godden had issues with the grass cutting tenders (377) . Mr Raybould advised that a Planning Officer would be re-visiting Victoria Cottages on 3 April (372). Representations were made regarding application PA12/01022 – construction of new bungalow, Bokelly Lane

389 Planning Notices

PA12/01022 – Mr G Williams, Land East of Springfield, Bokelly Lane – Construction of a new bungalow.

This was viewed by Cllrs Gabriel and Parnell. Cllrs Lethbridge and Hawkey declared an interest and left the room. After discussion it was proposed by Cllr Rowe and seconded by Cllr Mott that a site meeting be held on Friday 16 March at 4.30. All in favour

PA12/01638 – Mrs S Brobin, 3 Tretawn Close, St Kew Highway – Construction of a single storey extension

This was viewed by Cllrs Rowe and Mott.

It was proposed by Cllr Rowe and seconded by Cllr Mott that the Parish Council recommend **APPROVAL**. All in favour

389 Schedule of monthly accounts for February 2012

Cllrs R Godden, Davey, A Godden and Mott declared an interest and left the room. It was proposed by Cllr Gabriel seconded by Cllr Lethbridge that the monthly accounts be approved en bloc. All in favour.

390 Grass Cutting Tenders for 2012

Cllrs R Godden, A Godden and E Hambly declared an interest and left the room. Cllr Mott took the chair. Tenders were received from K Godden for £1,200 plus VAT and Wadebridge Garden Services for £1,100

It was proposed by Cllr Lethbridge seconded by Cllr Hawkey that the tender for £1,100 from Wadebridge Garden Services be accepted.

It was proposed by Cllr Davey seconded by Cllr Rowe that the tender for £1,200 plus VAT be accepted.

A secret ballot was held with Wadebridge Garden Services receiving 5 votes and K Godden receiving 2 votes. There was one abstention.

The Grass Cutting contract was therefore awarded to Wadebridge Garden Services

391 Footpath Tenders 2012

It was proposed by Cllr Rowe seconded by Cllr Parnell that the advert for the tenders for cutting be placed in the Parish Magazine. All in favour.

392 Diamond Jubilee

It was agreed to put this on next months Agenda to discuss distribution, numbers, and any other ideas for various events

393 Road Signs at Chapel Amble

Cornwall Council requires £3,500 to replace the signs. A quote for £1000 from a local contractor was sent to Cornwall Council but are not Highway approved. Enquiries are to be made for possible funding from Amble residents

394 Relocation of Parish Council Meetings

Discussion was held as to the benefits of moving the Parish Council Meeting to the Community Hall at St Kew Highway. As this appears to be booked for the 2nd Tuesday in the month, Cllr Lethbridge will make enquiries.

395 Parish Councillor reports and any other matters

Cllr Wellington reported Zig Zag Chapel – Salt bag had been stolen

Cllr Parnell proposed taking printed cards to planning site visits to advise neighbouring properties of details of applications. This was seconded by Cllr Rowe. All in favour.

Cllr Hambly advised of building taking place at the Piggery, Treburgett. This will be looked in to.

Cllr Rowe advised that Western Power had trimmed the trees around the street lights. There was more graffiti on the bus shelter and she would look into products that would make cleaning easier.

Cllr Mott reported that a Tree Preservation Order had been granted behind Whitehall Bungalows and Kenwyn. He also said that Councillors should attend the Community Network Meeting

Cllr R Godden reported that the book swap at the telephone box, Trequite was very successful but book needed to be borrowed as it is very full! Kathy Bevan volunteered to supervise the books.
