Minutes of the Meeting of St Kew Parish Council Meeting held on Tuesday 8th October 2019 at 7.00 pm in St Kew Parish Hall

20 members of the public were present.

6175. Public Discussion

There were a number of objections raised in relation to PA19/06113 and PA19/08173. The objections were in relation to access issues, possible contamination, lack of consultation, lack of community facilities and public transport as well as concerns raised on the Cornwall Council planning portal from other consultees as well as comments made suggesting that the Parish Council had previously passed favourable comment when no comment had been made either way. Differences in the plans submitted and google earth maps were also identified.

6177. Cornwall Councillor and Police Reports

Cllr Knightley recently attended a global warming conference which was interesting in relation to planning and environmental enhancement. He also provided an update on the turbine at St Dennis which was now working properly in dealing with the County's waste. Cllr Knightley also confirmed he would attend the Remembrance Service at St Kew this year.

6186. Christmas Tree

There was no need to purchase a tree this year and Cllrs were asked to volunteer to decorate the tree when required.

6187. Works at A R Bromfield & Sons, Trewethen Garage, Trelill

Cllr P Bishop and Cllr J Rowe had taken pictures of the works and general appearance of the yard from the road and concerns were raised over planning permission for any associated works and the correct disposal of any waste products.

PROPOSED by Cllr P Bishop and seconded by Cllr J Rowe that an email with the pictures be sent to Planning Enforcement. All in favour.

ACTION: Clerk to email Planning Enforcement to raise concerns and request appropriate action be taken.

6188. St Kew Churchyard

Cllr R Godden reported there was a triangular area in the churchyard that was totally overgrown and needed cutting back and clearing.

PROPOSED by Cllr R Godden and seconded by Cllr T Mott that the works go out to tender. All in favour.

ACTION: Cllr R Godden to advertise for tenders for the above works via the Parish Council's website and the Parish Magazine.

6189. Parish Councillor Reports and any other matters

Cllr Bishop reported that roadworks by Skisdon were due to be completed by the 11 October

Cllr Rowe reported that the new road markings at St Kew Highway had still not been carried out.

ACTION: Clerk to email Oliver Jones in Cornwall Council to request a commencement date for these works to commence.

Cllr Prophet reported that the Parish notice boards were starting to show signs of wear and tear.

ACTION: Cllr A Prophet agreed to carry out any required works to the notice boards to bring them up to an acceptable standard.

Cllr R Godden reported that roads in the parish, especially Regulator Road to Lanow Farm were in a bad state with excessive mud and debris.

ACTION: Clerk to notify Cornwall Council and request the roads be swept.
