## **Minutes of St Kew Annual Parish Meeting held on Tuesday 8<sup>th</sup> April 2018 at 7.00 pm in St Kew Parish Hall**

### **Chairmans Report**

Councillor John Lethbridge thanked his fellow Councillors for their support during the past year, which has been reasonably uneventful. He thanked County Councillor Knightley attending meetings whenever possible but found that Cllr Carol Mould had only attended one meeting in April 2017 immediately after the election, and had not been in contact with the parish since. This has left the Pendoggett Ward completely without representation.

He gave special thanks to Cllr Richard Godden who as the Responsible Finance Officer has an arduous task in keeping the accounts correct and compliant. He read the Commendation he had received from the auditors Aalgaard Renshaw:

“ A special mention is, again, given to Councillor Richard Godden for his co-operation during this process. The Parish Council is to be commended for the high standard to which it maintains its business records”

He also extended thanks to Cllr John Rickard for attending and reporting on the Community Network Meetings and to the Clerk for her hard work.

43 sets of plans have been discussed at Council meetings and each site had been viewed by two Councillors. 2 of our councillors resigned at the early part of the year, therefore the responsibility for site visits fell to the remaining few.

Good points this year were that the Common Land at Chapel Amble and Trequite have been cut and the Parish Council has helped to get the mobile Post Office. It is hoped that it will get full support to keep it running.

The problems this year have been with Cornwall Council Planning Department, who appear to ignore any recommendations or refusals made by the Parish Council, and whose decisions seem to be pre-determined before parish discussions. Similarly it seems the Enforcement Department enforce very little and do not support or uphold the Councils objections. This seems to make role of the Parish Council unnecessary
