**Clir Godden** remarked that parts of St Kew Churchtown were in poor repair and the area needed some attention.



#### Do you know who your External Auditor is?

All local councils in England have a new External Auditor.

Smaller Authorities Audit Appointments Ltd (SAAA Ltd), the body that appoints external auditors for our sector, has completed a procurement exercise that means councils will have a new auditor for the 2017/18 financial year. An audit pack containing an instruction letter and the new Annual Governance and Accountability Return (AGAR) is being distributed to every local council in England by appointed external auditors towards the end of March 2018. If these are not received by the second week of April, then authorities should contact their appointed auditor.

If you are unsure of who your new auditor is, please visit <a href="here">here</a>. This gives a list, county by county, of the auditor for that county and how to contact them. If you have any queries or concerns, you will need to contact SAAA using the contact details on the SAAA website.

#### **New version of the Practitioners' Guide**

The Joint Panel on Accountability and Governance ('JPAG', the body responsible for determining 'proper practices' for accounting and governance in England) has published the 2018 edition of Governance and Accountability for Smaller Authorities in England (the Practitioners' Guide).

Councils can prepare their Annual Governance and Accountability Return (AGAR) for 2017/18 in accordance with either the 2017 or the 2018 edition. The main change of substance is clarification on how councils should account for Community Infrastructure Levy. The new Guide can be downloaded here.

#### Locality announces new neighbourhood planning support

Locality has announced that it will be extending its support for local groups to develop neighbourhood plans for another four years following the Ministry of Housing, Communities and Local Government's (MHCLG) announcement of a new £23m programme.

The new neighbourhood planning programme will help thousands of local groups to create a neighbourhood plan or Neighbourhood Development Order. The 2018-22 programme will be different though, with changes to grant and support eligibility criteria.

The changes have also enabled a new and enhanced neighbourhood planning website (neighbourhoodplanning.org), a new <u>Twitter account</u> and quarterly newsletter, independent of the My Community programme.
